NOTIFICATION & ASSESSMENT OF LEVY PROCESS

The levy is payable on all eligible construction projects that started before 7 April 2014, of at least \$200,000 or more in value, and is calculated as a set percentage of the cost of the construction work on which it is imposed. A two tier levy regime applies to construction projects with total construction costs in excess of \$1 billion.

The following levy rates apply on projects that started before 7 April 2014 with construction costs from \$200,000 to \$1 billion:

- 0.5% on projects started from 01/07/2005 to 30/06/2009 - regardless of completion date,
- 0.4% on projects started from 01/07/2009 to 31/03/2012 - regardless of completion date &
- 0.3% on projects started from 01/04/2012 to 06/04/2014 - regardless of completion date.

Note: For projects that started on or after 7 April 2014, use form PNF 04

A Ministerially determined percentage rate will be applied to costs in excess of \$1 billion. Contact the NT Build Registrar for further information.

Unless particular construction work is exempted, sections 40 and 41 of the *Construction Industry Long Service Leave and Benefits Act (the Act)* requires:

- a person for whom the relevant construction work is being carried out, or
- a relevant entity that is to carry out construction work, to submit a completed Project Notification Form (PNF) notifying NT Build about the construction work.

This notification is required before the work starts on the site at which the construction work is to be carried out.

Generally, the total cost of the work is determined by the total contract prices for all the construction contracts in relation to the work. In accordance with section 37 of the Act, a "construction contract" has the same meaning as in the *Construction Contracts (Security of Payments) Act*.

As the total contract prices may not be known before work commences, the Board will usually accept a payer's self assessment of the estimated total contract prices.

For the administrative convenience of the payer and NT Build, an invoice in the amount assessed by the payer will be issued upon receipt of a PNF acceptable to the Registrar. The Act requires payment of the levy before work commences. However, the Board will accept payment of the invoice within 30 days of issue if the PNF is received before work commences. Interest will usually be applied to late payment of the levy if a PNF is not received before work commences.

At the completion of the project, a reconciliation of the actual total contract prices will be required, as an additional levy or refund may be payable once the final cost is known.

If a payer is unable or unwilling to self-assess the levy payable, or the Registrar does not accept the amount notified on the PNF, the Board will determine the levy payable in accordance with the Act.

In some cases, for example where there is no contract price for the work, the Board may need to determine the cost of construction for levy calculation purposes. In these instances, NT Build will require additional information, including:

- the cost of labour, materials (including prefabricated goods and installation), equipment, design, project management, consultancy and any other cost that directly or indirectly relates to the work; and
- if the construction work is to be carried out in stages or under a number of contracts or other arrangements the total cost in relation to those stages, contracts or arrangements.

NOTIFICATION & ASSESSMENT OF LEVY PROCESS

WHO CAN PAY THE LEVY BY INSTALMENTS

A person who is liable to pay an amount of the levy may apply to the Board for the payment to be made by instalments if the following criteria is satisfied:

- The amount of the levy exceeds \$10,000, and
- The time reasonably needed to carry out the construction work exceeds one year.

The first instalment must not be less than \$10,000 and must be paid to the Board at or before the time when the full amount of the levy would have been payable.

If a person fails to pay an instalment in accordance with an approved instalment proposal, the approval will cease to have effect and the amount of the levy that remains unpaid will become immediately payable, start to bear interest and be recoverable in a court of competent jurisdiction.
